

Terms & Conditions for the participation in the Emerging Leaders Program 2024

Updated and valid from 11. September 2023.

Program Participation Fee

For the participation in the Emerging Leaders program, a participation fee of 39.000 NOK excluding VAT will be charged. This fee covers all activities, meals, overnight stays and Arctic Frontiers conference tickets during the duration of the program. Note: this does not include travel to Bodø and back to the place of residency.

Payment Deadline

Payment for the participation in the Emerging Leaders program 2023 must be received by Akvaplan-niva AS no later than 23 November 2023.

Cancellation Policy

Please note that once participants have been accepted for the program, cancellations must be made by the 8 December 2023 to receive a full refund.

The organizers shall retain 20% of the total program participation fee if the cancellation is made after 8 December 2023. This is to cover expenses incurred by third party providers (e.g. hotel reservations and booked travel arrangements) that cannot be refunded to the organizers.

All cancellations must be made in writing and should be sent to emergingleaders@arcticfrontiers.com.

Cancellation of the Emerging Leaders Program

In the event that the Emerging Leaders program cannot be held or is postponed due to events beyond the control of the Emerging Leaders organizers (force majeure) or due to events which are not attributable to wrongful intent or gross negligence of the Emerging Leaders organizers, the Emerging Leaders organizers cannot be held liable by delegates for any damages, costs, or losses incurred, such as transportation costs, accommodation costs, financial losses, etc. Under these circumstances, the Emerging Leaders organizers reserve the right to reimburse the participants after deducting costs already incurred for the organisation of the Emerging Leaders program and which could not be recovered from third parties.
